Bachelor of Arts, DHE Approval

On March 14, 2019, MCLA was notified by the Massachusetts Department of Higher Education of the approval of MCLA's application to award the Bachelor of Arts in Communication. This degree will begin to be offered in fall 2019 with the first graduating class anticipated in 2020.

DESE Ruling on MCLA Department of Education

Vice President Williams provided an overview of DESE's formal review report of MCLA's PK-12 Education Preparation Programs, a copy of which was provided with the materials for this meeting. Trustees discussed the state's report and findings at length. VP Williams specifically reviewed the key areas for improvement, actions taken to-date, and stated management's and faculty's commitment to address and correct all concerns.

New Certificate Programs

VP Williams reviewed the proposals for Principles in Accounting and Network Security certificate programs which will be submitted to the Department of Higher Education if approved by the Board of Trustees at their April 4 meeting.

The courses as outlined in the proposals will be offered at 66 Allen beginning in fall 2019. Both certificate programs have been designed to allow credits to be applied toward a bachelor's degree with MCLA or an associate's degree with Berkshire Community College.

Upon motion duly made and seconded, it was unanimously:

VOTED: to recommend to the Board of Trustees approval of the Certificate in Principles of Accounting and Certificate in Network Security programs as presented.

Academic Affairs Initiatives

VP Williams announced that the Adult Basic Education (ABE) program would be transitioned to North Adams Public Schools systems at the end of AY 2020. With this transition, physical classroom space will allocated at the North Adams Armory.
